**NOTES TO AND FORMING PART OF THE ACCOUNTS
FOR THE YEAR ENDING 30 JUNE 2012**

1. Statement of Accounting Policies

This is a special purpose financial report prepared for the members as required by the constitution of the Association. The committee has determined that the entity is not a reporting entity as defined by the Accounting profession. Therefore, there is no requirement that the pronouncements of the Australian Accounting profession be applied, and so the report has not been prepared in accordance with Australian Accounting Standards or other authoritative pronouncements.

2. Commuter Club

Cash payments for Commuter Club tickets may be received from members in a different accounting period from the associated cash remittance made by the Association to the ticketing authority. As the Association's financial report is prepared on a cash basis, the statement of income and expenses may include cash receipts related to orders made in a previous or subsequent financial year, and/or exclude cash receipts related to orders made in this financial year. Therefore the statement of income and expenses may over or understate the commission earned on orders made in this financial year.

During this financial period, it included associate membership of the Metropolitan Transport Forum and Consumers Federation Australia, costs related to the 2011 Annual General Meeting and other members' meetings, transport publications, write-down of inventory and annual statement fees.

4. Investment Account

With reference to Note 6, any contingencies payable will be met in part from this account.

5. Contingencies

P Allan, a member of the Association, was a litigant in respect to the City Link Tax Free concessions. A previous committee agreed to indemnify him for up to \$14,000, if he is required to pay costs.

6. Charges on the Association

There are no mortgages, charges or securities of any description affecting any property of the association.

7. Auditing of Accounts

There is no formal requirement for the association to have its accounts audited externally. As at the date of the AGM, this has not been arranged.
